Overall flood risk













Jointly Developing and Sharing Information

- Overall Flood Risk
- 1. Flooding will happen
 - 100-year flood = 1% chance of flood occurring each year
- 2. No levee is flood-proof
 - 100-year levee = 26% chance of flooding over 30 years
- 3. Risks associated with flooding vary
 - Probability of flooding
 - Levee size and condition
 - Location of residences, businesses, infrastructure
- 4. Actions taken now will save lives and property
 - Risk communication
 - Community actions
 - Private citizen actions
 - Flood insurance









Partnered Implementation of Silver Jackets Efforts

- Flood preparedness public workshops
 - ✓ Four regional workshops
 - Illinois Emergency Management/USACE/FEMA/USACE/NWS
 - Well attended and supported
- Joint agency presentations at conferences
 - ✓ Illinois Association of Floodplain and Stormwater Managers Annual Conference
 - IDOT Annual Hydraulic Engineers Meeting
 - Topics: flood risk, levee inspections, rehabilitation, certification, accreditation
- Silver Jackets representation at State EOC
- Joint agency deployment to impacted areas









Results of Improved Coordination:

- Well attended conferences and workshops
- Better informed agencies, communities, and public
- Overall improved public's understanding of:
 - ✓ Their flood risk
 - How to prepare for and respond to flooding
 - ✓ How to work with Local, State, and Federal agencies
